## INSTALLATION TIPS

- Acurio Lattice can be fabricated and installed with conventional woodworking tools.
- Panels can be cut down to size with a circular saw. We suggest using a carbide tipped blade with fine teeth.
- #8 stainless steel, triple galvanized, or ceramic coated screws are recommended.
- Frame the panel on all 4 sides with pressure treated lumber and/or trim.
- Always store sheets on a flat surface until installation to prevent deformation of product.
- Although it is not necessary, Acurio Lattice may be painted. Latex based paint is recommended.
